Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

Mr. Will Alexander



I've been involved in the world of purebred dogs for as long as I can remember. My family bred and showed Irish Setters, and as a junior I began breeding English Cockers under the Wilspride prefix. After apprenticing with Garry MacDonald in Canada and Bobby Stebbins in the United States, I turned professional in 1986. The following year, I made history by handling Ch. McCammom Impresario, an Irish Setter, to Top Dog All Breeds, becoming the youngest handler ever to earn that distinction. Over the years, I've had the privilege of working with many of Canada's top-winning dogs, including several in the Terrier Group. I have shown Border Terriers earning multiple Best in Show and National Specialty wins with the breed. Their soundness, confidence, and honest working character have given me a lasting appreciation for Terriers and the qualities that make them so special to evaluate. I co-own two Borders, one currently in the show ring and the other is now spending most of his time in performance events. Today, I continue to share my experience through DogShowTips.com and my seminar series "Handle Your Way Out of a Paper Bag." Whether I am judging, teaching, or simply watching dogs work, I remain inspired by the dedication and purpose that define our sport and the breeds we love.

Ms. Cathy Barlow



Cathy has bred, owned and exhibited Golden Retrievers and English Springer Spaniels under the kennel name Tasmara and Barcath since 1975.

She has been judging since 2005.

Mr. Davor Javor



I've been interested in dogs since I was a kid, I just love dogs. My first dog was an American Cocker bitch, Champion and my first BIS winner. We've had Champion Afghan Hounds and English Cockers as well. Today we only have Old English Sheepdogs under the kennel name Reata. The OES's that we bred have won their championships all over the World, including World, European, English, American, Australian championships and champions in almost every European country!

We have BIS winners in Europe, South and North America, RBIS at European Dog Show, Group Winners both at the World and European Shows, WD and two times AOM at the American National, two times BIS at the Euro-OES Show, BOB at Crufts etc. Our last big result was with an OES from our breeding who won Group 2nd at the World Dog Show 2021. We achieved all that never having more than five adults at home.

I've been judging dogs for almost 35 years, and I am approved by the Croatian KC and FCI as an all-round judge. I have judged so far in Argentina, Austria, Australia, Bosnia and Herzegovina, Canada, China, Croatia, Colombia, Czech Republic, Denmark, England, Estonia, Finland, France, Germany, Honduras, Holland, Hungary, Italy, Israel, Latvia, Lithuania, Mauritius, Mexico, Norway, Philippines, Poland, Portugal, Russia, Serbia, Slovakia, Slovenia, Spain, Sweden, Ukraine, USA and Yugoslavia. In 2019 I've

judged BIS on 6 continents including BIS at Sydney Royal.

I am very proud that I am first Croatian judge who gave CC's in UK. In 2014 I received an Award for lifetime achievement in breeding from Croatian KC. Author of many articles about dogs in different magazines, I have given lectures about dogs to different audiences, from beginners to judge's organizations.

I am married, have 2 wonderful kids, have Master's degree in computer sciences, and still breeding OES.

Ms. Ainslie Mills



Oriana (CKC Perm. Reg.) Golden Retrievers since 1974. Ainslie has participated in conformation, rally and obedience with some interest in working certificate/junior hunter training and tracking. Ainslie and her husband Barrie have bred and/or owned over 60 champions, Obedience Trial champions, Group and High in Trial winners, as well as junior hunters, tracking dogs, guide dogs for the blind, therapy dogs, search and rescue dogs and avalanche rescue dogs. In 1993, Robbie, a black Labrador entered their lives, enriching it for over 14 years, educating them in the ways of Labradors and endearing them to this wonderful breed.

Ainslie is a Life Member of the Canadian Kennel Club, Golden Retriever Club of Canada, Golden Retriever Club of America and GRC of BC and also a member of the Golden Retriever Club (UK). She has held numerous offices with both the national and local Golden clubs, including GRCBC newsletter editor and, for 11 years, coordinator of the GRCBC Rescue and Adult Placement Service. She is presently Chair of the GRCC Breed Standard/Judges Education Committee and chaired the Judges Education Committee for the Golden Retriever Club of America for 15 years. She has served three terms on the Canadian Kennel Club Breed Standards Committee.

For eight years in the 1990s, Ainslie hosted and produced All About Pets, a monthly, live, one-hour program for Rogers Community TV, sponsored by the Western Federation of Individuals and Dog Organizations (FIDO). She is a former Board Member and volunteer with the B.C. Branch of Canadian Guide Dogs for the Blind and was a founder of the former Sporting Dog Spectacular weekend in British Columbia.

Ainslie applied to judge conformation in 1991 and is now approved by the Canadian Kennel Club to judge all breeds. She has had the privilege of judging throughout Canada and the United States as well as Australia (4x), Argentina, Indonesia, Scotland and New Zealand (2x). Ainslie has judged a number of Sporting, Hound, Working and Herding breed specialties, including ASCA (Australian Shepherd Club of America) specialty shows, and sighthound show and go events, which combine coursing and conformation. She was very honored to judge at the Golden Retriever Club of Canada National Specialties in 1998, 2002 and 2016. In 2004, she judged a record entry of over 430 Golden Retrievers at the Australian Golden Retriever National Specialty and assessed over 300 bitches at the Golden Retriever Club of America National Specialties in 2004 and 2021. She judged the Nova Scotia Duck Tolling Retriever Club of Canada National Specialty in 2009.

Mr. Fabricio Pastor



Born in Ecuador.

My career had its beginnings in Cali, Colombia when I purchased my first SharPei specimen.

By attending several dog events I was suddenly invited to the Colombian Ralston-Purina Ranking where my Shar Pei won 1st place. This experience encouraged me to keep on learning about this sport, and it was then that I decided to open my own breeding place under the name P'elarena which is registered under the FCI (Federation Cynologique Internationale).

I was an active member of the Club Canino del Valle (Cali) and sometime later I imported two American Shar Pei champion specimens to develop my breeding project. I earned my degree as a Publicist in Colombia before I returned to Ecuador where I imported my first female American Cocker Spaniel. After studying the Basenji breed, I purchased my first female puppy and afterwards began raising the Papillion breed. I've managed to obtain championships with several specimens from my breeding place inside and outside of Ecuador with a total of 24 Ecuadorian champions, 8 multi-Ch's

BIS/BIS placements and my first American Champion.

Being a member of the Chinese Shar Pei Kennel Club of America, I have assisted and participated in several courses and contests obtaining an Award of Merit – AOM in Orlando, Fl. which became my biggest achievement as a handler.

I also exhibit other breeds such as Labrador, Golden Retriever, Brittany, Rottweiler, Rhodesian Ridgeback, miniature Schnauzer, Dachshund, English Bulldog and Bull Terrier.

In 2006 I got my All-breed judging license from the Ecuadorian Association of Canine Records – AERCAN and I'm a currently an active member and part of the Board of the same organization as their Director of Foreign Relations till 2025.

*I received the AKC judging approval in September 2018.

Grooming Judge since 2022. President of Santa Elena Kennel Club (AERCAN delegation) since 2023.

I have judged in countries, Uruguay, Portugal, Dominican Republic, Italy, Spain, United States of America, Canada, Bolivia, Panama, Brazil, Australia, Colombia, Chile, Ecuador, Mexico, Peru, Venezuela, Bolivia, New Zealand, Malaysia, Cuba, Costa Rica, El Salvador, Guatemala, Argentina and Americas and the Caribbean Dog Show (Ecuador), World Dog Show Brazil 2022.

Kim has been showing dogs since 1988 and has bred Cavalier King Charles Spaniel and English Springer. She has been judging since 2007 and has judged in Canada and USA.

CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS - This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE BREED JUDGING** on that day. TCN Fees **WILL NOT** be refunded

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

NON-REGULAR CLASSES

PUPPY CLASS - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and **PRIOR** to Best in Show)

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

BREEDER/OWNER/HANDLER- you must enter this class (no fee) to be considered. From regular classes only. You must handle the dog for all levels of competition.

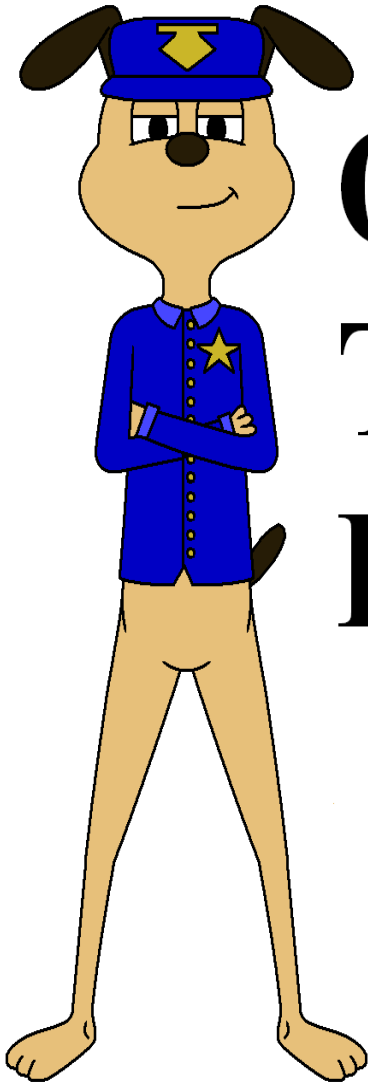

PLEASE REMEMBER TO CLEAN UP AFTER YOUR DOG. Any exhibitor caught not cleaning up after their dog will be subject to expulsion from further competition. Please... to **ensure our continued use of this site.**

No dogs are permitted in the washrooms.

Exhibitors may not dispose of water from buckets or tubs in the garbage cans.

Do **NOT** overfill the garbage bins, please let a club member know that they are full.

The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.

The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the club table.

UNSPORTSMANLIKE CONDUCT

11.1 It shall be deemed unsportsmanlike conduct if a person, during the running of or in connection with an event, abuses or harasses a judge, show official or any other person present in any capacity at the event.

Anyone found to be unkind, especially to minors, will be asked to leave the event - no refunds! Investigation will follow with possible further consequences. Be humble....be kind.

2. ENTER Online



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

ALL Entries **MUST** be received by closing date: **WEDNESDAY, June 24th, 2026 @ 9:00pm Pacific Time**

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

BREEDER/OWNER/HANDLER COMPETITION (BOH - Sunday)

Unofficial/Exhibitor Eligibility

1. Exhibitors must declare their dog eligible for Breeder/Owner/Handler Competition at the time of entry using the check box on the entry form (either paper or electronic). If the handler changes from the time of entry to exhibition, the exhibitor is responsible for advising the ring steward if the entrant is no longer eligible.
2. The handler must be a breeder/owner of record listed in the catalogue.
3. Dogs must be handled by a listed breeder & handler throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. The same is true for all levels of group and show competition.
4. The BOH in Breed will be selected from the eligible dogs that competed in the Best of Breed competition for the regular show. This includes Winners Dog, Winners Bitch. This excludes all dogs defeated during class and winners competition for the regular show.

Determining Best BOH in Breed

The selection of the Best BOH in Breed is held immediately following regular judging of that breed in the same ring. The ring steward will excuse all exhibitors not eligible. The judge will then award Best BOH in Breed. Judging of the breed for the regular show may determine the dog that is awarded the Best BOH in Breed.

Guidelines:

- If the Best of Breed winner of the regular show is eligible for Best BOH in Breed it will also be awarded Best BOH in Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for Best BOH in Group.
- If the regular show Best of Breed winner is not eligible for Best BOH in Breed and the regular show Best of Opposite Sex is eligible, the regular show Best of Opposite Sex will compete against the eligible exhibits of the other sex to determine Best BOH in Breed.
- If neither the Best of Breed nor the Best of Opposite Sex from the regular show is eligible for the Best BOH in Breed and both the Select Dog and Select Bitch are eligible, the judge is to choose Best BOH in Breed from the Selects and any eligible Winners Dog or Winners Bitch.
- If one of the Selects from the regular show is eligible for Best BOH in Breed, excuse all eligible champions and then choose Best BOH in Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.
- If the regular show Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as the Best BOH in Breed.

If no dog remaining in the ring is eligible for the Best BOH in Breed competition, no award will be made and there will not be representation in group competition for the Best BOH in Group.

Group and Best in Show Competition

- In the Group and Best in Show competition, the dog must be handled throughout the competition by an eligible breeder.
- Group judging for the Best BOH in Group may take place in separate rings from regular group judging.
- Judging for the Best BOH in Show is after regular Best in Show judging.

JUVENILE SWEEPSTAKES - FRIDAY, July 10th, 2026, noon

Judge: Candice Jensen

Juvenile Sweepstakes is to all puppies six months and under eighteen months of age regardless of place of birth. All dogs must be entered in one of the regular official classes on the same day. Dogs will be judged in one of the following three classes (divided by sex):

- Junior Puppy - 6 months and under 9 months
- Senior Puppy - 9 months and under 12 months
- Juvenile Puppy - 12 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

Best in Sweepstakes - rosette & 50% of total fees collected for the Juvenile Sweepstakes

Best of Opposite in Sweepstakes - rosette & 25% of total fees collected for the Juvenile Sweepstakes

25% of fees collected will be retained by the club to defray costs

VETERAN SWEEPSTAKES - FRIDAY, July 10th, 2026 following Juvenile Sweepstakes

Judge: Candice Jensen

Veteran Sweepstakes is open to all dogs 7 years of age and over and entered in a regular class or for exhibition only on the same day. Spayed and neutered dogs may compete provided they are also entered in exhibition only.

Dogs to be judged in one of the following two classes (divided by sex):

- 7 years and under 10 years
- 10+ years

For final judging the first place winner from each of the classes will be brought together for the final judging of Best in Veteran Sweepstakes.

Best in Sweepstakes - rosette & 50% of total fees collected for the Veteran Sweepstakes

Best of Opposite in Sweepstakes - rosette & 25% of total fees collected for the Veteran Sweepstakes

25% of fees collected will be retained by the club to defray costs

JUNIOR HANDLING - SATURDAY, JULY 11TH, 2025 AT NOON

Judge: Candice Jensen

Entries will be accepted at the show secretary's desk up to 11:00 am on Saturday with no exceptions.

Entry Fee \$2.00

The following classes will be provided:

Pee Wee (non-competitive) - 4 to 6 years

Junior Novice - 7 to 10 years

Junior Open - 7 to 10 years

Intermediate Novice - 11 to 14 years

Senior Open - 15 to 18 years

Note: Pee Wees do not compete for best overall.

This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked."

GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog **BEFORE** taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.
13. The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.
14. Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please **DO NOT** make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.
15. No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level.

In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022



AGREEMENT

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
